We, Melvin E. Sammons and Muriel T. Sammons, of Greenville County,

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Ten Thousand and No/100-----(\$ 10,000,00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville. being known and designated as Lot 310 of a subdivision known as Botany Woods Sector VII according to a plat thereof prepared by Piedmont Engineering Service, June 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book YY at Pages 76 and 77 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northwestern side of Bridgewater Drive, joint front corner of Lots 310 and 311 and running thence with the joint line of said lots, N. 17-21 W. 180 feet to an iron pin, joint rear corner of Lots 310 and 311; thence with the rear line of Lot 310, S. 72-39 W. 130 feet to an iron pin, joint rear corner of Lots 309 and 310; thence with the joint line of said lots, S. 17-21 E. 180 feet to an iron pin on the northwestern side of said Bridgewater Drive, joint front corner of Lots 309 and 310; thence with the northwestern side of said Bridgewater Drive, N. 72-39 E. 130 feet to the point of beginning; being the same conveyed to us by W. C. Balentine by deed of even date to be recorded herewith."
