"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the eastern side of Texas Avenue near the City of Greenville being shown as Lot No. 19 of Block O on a plat of Highland made by Dalton & Neves in July 1940 recorded in the R. M. C. Office for Greenville County in Plat Book "K", at Pages 50 and 51 and described as follows:
