NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate near the City of Greenville, Chick Springs Township, on the northern side of Lee Road Extension (formerly known as Edwards Road), and having the following metes and bounds, to wit:

"BEGINNING at an iron pin on the north side of Lee Road Extension, and running thence N. 12-52 E. 215 feet to an iron pin; thence running S. 80-42 E. 70 feet to an iron pin; thence S. 12-52 W. 215 feet to an iron pin on the northern side of Lee Road Extension; running thence along the northern side of Lee Road Extension N. 80-42 W. 70 feet to an iron pin, the point of beginning."

Being the same property conveyed to the mortgagor by W. E. Shaw, Inc. by deed to be recorded herewith.
