"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situated on the East side of South Trade Street in the City of Green, Chick SpringsTownship, being Lots No's 1 and 2 of the W.A. Rogers Estate according to survey and plat by R.W. Dalton, dated March, 1924, and having the following courses and distances, to-wit:-
