"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the White Horse Road, bounded by lands of Clara H. Davis and lands now or formerly owned by Clem Moore, H. O. Huff and Burdine and according to a plat made by L. Coke Smith on March 30, 1955, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the line of the property of the above named Clara H. Davis and property of H. O. Huff and running thence with the property of Huff S. 30-30 E. 367 feet to an iron pin; thence S. 62-00 W. 417.9 feet to an iron pin in line of property of Burdine; thence with property of Burdine, N. 62-00 W. 367 feet to an iron pin; thence with the property of Clara H. Davis, W. 55-14 E. 612.8 feet to an iron pin, point of beginning.
