All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about 2 miles Northwest of Greer, on the East side of Dogwood Avenue, and being known and designated as lot no. Two (2) of the W. Dennis Smith property as shown on plat prepared by H. S. Brockman, Registered Surveyor, dated Sept. 14, 1957 and which plat has been recorded in the R. M. C. Office for said county in Plat Book NN, page 168, and having the following courses and distances, to-wit: Beginning at a Stake on the East side of Dogwood Avenue at the joint front corner of lots nos. 1 and 2 as shown on said plat, and running thence with the joint property line of said two lots N.88-17 E.192.8 feet to the joint rear corner of lots nos. 1, 2, 9 and 10 as shown on said plat, thence with the joint rear property line of said lots nos. 2 and 9 N.O-10 W.102.5 feet to the joint rear corner of lots nos. 2, 3, 8 and 9 as shown on said plat, thence with the joint property line of said lots nos. 2 and 3 S.89-29 W.192.8 feet to a Stake on East side of Dogwood Avenue, thence with the East side of Dogwood Avenue S.O-10 E.95 feet to the beginning point.
