Township, on the south side of U.S. Highway No. 29 about one mile westward from the City of Greer, and being shown as the property of William B. Ducker according to survey and plat by Dalton & Neves, Engineers, dated December, 1964, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the south right-of-way line of said highway, corner of L.C.
