All those parcels or lots of land in the City of Greer, Chick Springs Township, Greenville County, South Carolina, located on the east side of North Main Street and the south side of Fairview Avenue being all of Lot No. 5 and the northern portions of Lots Nos. 8 and 9 as shown on plat recorded in Plat Book "A", page 299, in the R.M.C. Office for Greenville County, and having the following courses and distances:

BEGINNING at a point at the intersection of North Main Street and Fairview Avenue, and runs thence along the margin of Fairview Avenue, S. 82-35 E. 303 feet to a stake; thence S. 7-25 W. 85 feet to a stake; thence N. 82-35 W. 128 feet to a stake; thence N. 7-25 E. 20 feet to a stake; thence N. 82-35 W. 175 feet to a stake on the east side of North Main Street; thence along the margin of said street, N. 7-25 E. 65 feet to the beginning.
