All that certain parcel or tract of land containing 13 acres, more or less, situated on the highway leading from the Jack Carlton Store (formerly Coleman's store) at Sandy Flat to the Mays Bridge Road, Oneal Township, Greenville County, State of South Carolina, bounded by lands of John Crain, John S. Joins and Dr. McGill, and being a portion of Tract No. 1 of the J.A. Fowler land according to survey and plat by H.S. Brockman, Surveyor, dated August, 1919.
