AND IT IS AGRRED, by and between the said parties that upon any default being made in the payment of the interest or principal on the said Note or of the insurance premiums, or of the taxes, or of the assessments hereinabove mentioned, when the same shall severally become payable, or in the event of default in the performance of any one of the terms or conditions of the Master Mortgage hereafter more particularly described, or of any of the other terms or conditions of this Mortgage, then the entire amount of the debt secured or intended to be secured hereby shall become due, at the option of the said Mortgagee, its successors or assigns, although the period for the payment thereof may not then have expired.
