"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, located on the south side of the Pelham Road, containing 1.23 acres, more or less, and having courses and distances according to survey by W.J. Middle, dated May 7, 1951, as follows, to-wit:

BEGINNING at a point in the center of the Pelham Road at the northwest corner of the McIntyre property, and running thence with the line of the McIntyre property, S. 25-28 E. 281.8 feet to an iron pin; thence S. 81-40 W. 235.2 feet to an iron pin; thence N. 10-50 W. 269.6 feet to a point in the center of the Pelham Road; thence along the center of the said road, N. 81-40 E. 163.8 feetto the beginning corner, being the same property conveyed to the mortgagors herein by F. Bert Ponder by deed recorded in the R.M.C. Office for Greenville County.

Bert Ponder by deed recorded in the R.M.C. Office for Greenville County.
