WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgager) in the full and just sum of

All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the west side of Pimlico Road, being shown as Lot No. 419 on plat of Section D, Gower Estates, made by H. C. Clarkson and R. K. Campbell, May 1964, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book RR, pages 192 and 193 and having, according to said plat, the following metes and bounds, to-wit:
