NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagore according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagore. gagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee, Kate Greer Dill and her heirs and assigns:

All that parcel or lot of land in Chick Springs Township of Greenville, South Carolina, located on the south side of the Brushy Creek Road, and near the corporate limits of the City of Greer, being shown as Lot No. 11 on a plat made for Hoyt Walters by C.C. Jones, C.E., dated August, 1964, and having the following courses and distances:

BEGINNING on an iron pin on the southeast side of the Brushy Creek Road, joint corner with property heretofore conveyed to Sidney Sloan, and runs thence with Sloan's line, S. 53-30 E. 75 feet to an iron pin; thence S. 36-30 W. 140 feet to an iron pin on the margin of new cut street; thence with the margin of said street as follows: N. 53-30 W. 90 feet to a stake; thence N. 36-45 W. 47.9 feet to a stake and N. 24-44 E. 26.1 feet to a stake on the margin of Brushy Creek Road; thence therewith N. 69-44 E. 120.5 feet to the beginning.

This is a purchase money mortgage, the same being given to secure payment of the purchase price of said lot. It is understood and agreed that this mortgage is junior in priority and is to be second to a mortgage given, or to be given by Hoyt Walters to Fidelity Federal Savings and Loan Association of Greenville, S.C., the mortgage to be given to that institution, it is agreed, shall constitute the first and preferred lien on the real estate described herein.
