All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, near the City of Greer, on the easterly side of Lee Circle, and being shown and designated as Lot No. 9, on plat of Maple Heights, prepared by H. S. Brockman, RLS, August 29, 1958, said plat being recorded in the RMC Office for Greenville County, S. C., in Plat Book "MM", at Page 31, and having according to said plat and to a more recent plat of property of John C. Surner prepared by G. A.
