Beginning on the 15th day of June, 1965, and on the 15th day of each month of each year thereafter the sum of \$577.04, to be applied on the interest and principal of said note, said payments to continue up to and including the 15th day of April, 1975, and the balance of said principal and interest to be due and payable on the 15th day of May, 1975; the aforesaid monthly payments of \$577.04 each are to be applied first to interest at the rate of five and one-half $(5\frac{1}{2}\%)$ per centum per annum on the principal sum of \$53,168.62, or so much thereof as shall, from time to time, remain unpaid, and the balance of each monthly payment shall be applied on account of principal.

IT IS FURTHER UNDERSTOOD that all other terms, stipulations and conditions contained in the said note and mortgage shall remain as written except as herein modified.
