MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Herbert Neil Mauldin, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, being known and designated as Lot No. 14 of a subdivision known as Mauldin Meadows as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 151, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Mauldin Circle, joint front corner of Lots 13 and 14, and running thence with the joint line of said lots, N. 46-15 W. 133.8 feet to an iron pin; thence S. 45-25 W. 104.1 feet to an iron pin, joint rear corner of Lots 14 and 15; thence with the joint line of said lots, S. 57-57 E. 144.3 feet to an iron pin on the northwestern side of Mauldin Circle; thence with Mauldin Circle, following the curvature thereof, the chord of which is N. 37-17 E. 53.3 feet to an iron pin; thence continuing with Mauldin Circle, N. 43-45 E. 21.7 feet to the beginning corner; being the same conveyed to me by J. H. Mauldin by deed dated June 28, 1957 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 579, Page 381.
