NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Wembley Road in the City of Greenville, known as Lot No. 288 on plat of Section B of Gower Estates, made by R. K. Campbell, Surveyor, December 1961, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book XX at pages 36 and 37, and having according to said plat, the following metesand, bounds, to-wit:

BEGINNING at an iron pin on the east side of Wembley Road at joint front corner of Lots 287 and 288, and running thence along the line of Lot No. 287, S. 83-59 E. 157.7 feet to an iron pin; thence S. 10-45 W. 81 feet to an iron pin; thence with the line of Lot No. 289, N. 83-29 W. 161.2 feet to an iron pin on the east side of Wembley Road; thence along Wembley Road N. 13-19 E. 80 feet to the beginning corner.

Being the same property conveyed to the Grantor herein by deed of M. R. Hamby, Jr., of even date herewith, to be recorded in the RMC Office for Greenville County, South Carolina.
