All that certain piece, parcel or lot of land lying and being on the northwesterly side of Prescott Street in the City of Greenville, S. C., being known and designated as Lot No. 45 and the northern one-half (1/2) of Lot No. 46 on plat of Isaqueena Park as recorded in the RMC Office for Greenville County, S. C. in Plat Book P, pages 130 and 131, and having according to a more recent survey prepared by R. K. Campbell entitled "Property of B. L. Pack", the following metes and bounds, to-wit:
