To ALL WHOM THESE PRESENTS MAY CONCERN: We, L. S. Thomason & Barbara M. Thomason, of Greenville, South Carolina, hereinafter called the Mortgagor, send (s) greetings:

ALL that piece, parcel or lot of land located in the County of Greenville, State of South Carolina, situate, lying and being on Conley Street and being known and designated as Lot No. 25 (House No. 7) according to a plat of BELMONT HEIGHTS as recorded in the R.M.C. Office for Greenville County in Plat Book "GG" at pages 54 and 55.

Lot dimensions are 100 x 206.5 x 110 x 209.5.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
