Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

> ALL that piece, parcel or lot of land in the State of South Carolina, County of Greenville, known and designated as Lot #98 and part of Lot #97 on plat of Anderson Street Highland, recorded in Plat Book J at page 157, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of East Sommerset Avenue (formerly East King Street) at joint front corner of Lots #98 and #99, which iron pin is situated 407.8 feet from the intersection of East Somerset Avenue and Anderson Road and running thence along the line of Lot #99, North 42-40 East 150 feet to an iron pin; thence with line of Virginia-Carolina Chemical Company South 47-20 East 75 feet to an iron pin in center of rear line of Lot #97; thence through center of Lot #97 South 42-40 West 150 feet to an iron pin on the Northeastern side of East Somerset Avenue, which pin is situate in front line of Lot #97; thence with East Somerset Avenue, North 47-20 West 75 feet to the point of beginning.
