ALL that lot of land with the buildings and improvements thereon situate on the Southeast side of Pine Creek Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 319 on plat of Section 3 of Belle Meade Subdivision, recorded in the RMC Office for Greenville County, S. C., in Plat Book GG, Page 187; said lot fronting 81 feet along the Southeast side of Pine Creek Drive, running back to a depth of 130 feet on the Northeast side, to a depth of 130 feet on the Southwest side, and being 81 feet across the rear.
