NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Creighton Street shown as Lot No. 3 on plat of Colonial Hills, Section 2 recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 185 and being further described as follows:

BEGINNING at an iron pin on the western side of Creighton Street at the joint front corner of Lot Nos. 3 and 4 and running thence along the line of Lot No. 4, N. 80-15 W. 150 feet to an iron pin; thence N. 9-45 E. 100 feet to an iron pin at the joint rear corner of Lot Nos. 2 and 3 and running thence along the line of Lot No. 2, S. 80-15 E. 180 feet to an iron pin on the western side of Creighton Street; thence along the western side of Creighton Street; thence along the western side of Creighton Street, S. 9-45 W. 100 feet to the point of beginning.
