"ALL that certain piece, parcel or lot of land, with all Improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in that section known as San Souci, about two miles north of the City of Greenville on Blue Ridge Drive, between Belmont Avenue and King Street, said lot having the following lines, courses and distances:

BEGINNING at an iron pin on the northern edge of a five foot sidewalk running along Blue Ridge Drive, said pin being the joint front corner of Lots 4 and 5, and running thence along the northern edge of said sidewalk on Blue Ridge Drive S. 87-37 W. 65 feet to an iron pin, joint front corner of Lots 3 and 4; thence along the eastern line of Lot 3 N. 5-49 W. 175.7 feet to an iron pin, joint rear corner of said Lots 3 and 4; thence N. 79-28 E. 65 feet to an iron pin, joint rear corner of Lots 4 and 5; thence with the western line of Lot 5 S. 5-51 E. 184.7 feet to an iron pin on the northern edge of said sidewalk, the beginning corner, said lot being known and described as Lot 4, on plat of property recorded in the R.
