NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, on the south side of Clark Avenue near the City of Green and southward therefrom, being Lots Nos. 73 and 74 of BROOKHAVEN, property of the Dobson Astates according to survey and plat by H.S.
Brockman, Registered Surveyor, dated December 12, 1957, recorded in Plat Book MM, page 85, R.M.C. Office for Greenville county, and having the following courses and distances:

BEGINNING at an iron pin on the south side of Clark Avenue, corner of Lots Nos. 72 and 73, and running thence along the line of said lots, S. 11-02 W. 293 feet to a branch; thence down said branch, S. 86-56 E. 101 feet and N. 76-20 E. 110.1 feet to corner of Lot No. 75; thence along the line of Lot No. 75, N. 11-02 E. 233 feet to an iron pin on Clark Avenue; thence along said Avenue, N. 79-25 W. 200 feet to the beginning corner.
