"ALL that certain piece, percel or lot of land, with all improvements thereon, or hereafter constructed thereon, slauste, lying and being in the State of South Carolina, County of Greenville known and designated as Lot No. 94 on a plat of Nicholtown Heights Map no. 2, made by W. J. Riddle, Surveyor, in 1941, recorded in the RMC Office for siad County and State in Plat Book "M" at page 5, said lot having a frontage of forty (40) feet on River Street and a depth in parallel lines of 116.4 geet, and being the lot conveyed to grantors by J. A. Fortner by dded recorded August 8, 1955 in deed book 532 page 353, of the RMC Office for Greenville County.
