Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township containing 50.8 acres, more or less, and being a portion of the Carrie M. Black property and having the following metes and bounds, towit:

BEGINNING at an iron pin in the center of Meece Bridge Road at the corner of property conveyed to Bruce and property of J. T. Edwards and running thence N 63-45 E 1387.36 feet to an iron pin; thence S 19-40 E 377.52 feet to an iron pin; thence along a branch the courses and traverses of which are due S 165 feet; S 12-30 W 118.8 feet; S 4E 264 feet; S 57-45 W 123.42 feet; S 18 W 268.62 feet; S 9-30 E 462 feet; thence S 64 W 1205.16 feet; thence N 20-40 W 1215.58 feet to an iron pin in the center of Meece Bridge Road; thence following the center of said road the following courses and distances, to-wit: N 52-47 E 150 feet; N 33-32 E 150 feet; N 14-49 E 218.4 feet to the point of beginning.
