MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Henry W. Holmes and Elizabeth P. Holmes, of Greenville County,

......(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Spring Forest Road near the City of Greenville, being shown as Lot No. 37 on a plat of Spring Forest, recorded in Plat Book XX at Page 126 and being described as follows:

"BEGINNING at an iron pin on the southern side of Spring Forest Road at the corner of Lot 38, and running thence with the curve of the southern side of said lot, the chords of which are: S, 75-43 E. 60 feet and S. 62-47 E. 60 feet to an iron pin at the corner of Lot 36; thence with the line of said lot, S. 29-30 W. 180 feet to an iron pin at the corner of Lot 44; thence with the line of said lot, N. 73-12 W. 56.6 feet to an iron pin at the corner of Lot 38; thence with the line of said lot, N. 9-46 E. 185.2 feet to the beginning corner; being the same conveyed to us by McCall-Threatt Enterprises, Inc. by deed dated February 1, 1966 to be recorded herewith."
