ALL that piece, parcel or lot of land with the buildings and improvements situate, lying and being on the east side of Westview Avenue, in the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 10 and the northern portion of Lot No. 11 of Block 1, Section A, on plat of Parkvale, made by Palton & Neves, Engineers, June 1940, recorded in the RMC Office for Greenville County, S. C., in Plat Book K, page 52, and having according to said plat and a survey made by R. K. Campbell March 31, 1966, the following metes and bounds, to-wit:
