"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, on the north side of the road leading from Milford Church to Double Springs Church, near Gilreath's Fill, and being a portion of Lot Mo. 7 of the F.G. James Property, plat thereof by H.L. Dunahoo, Surveyor, dated October 1, 1947, and having the following courses and distances, to wit:

Beginning on a nail and stopper in the center of said road, and running thence N. 28-25 E. 197 feet to an iron pin; thence S. 32-45 E. 96.1 feet to an iron pin, corner of Lots Nos. 3 and 4 on line of Lot No. 7; thence S. 9-45 W. 172.5 feet to a nail and stopper in the center of the road; thence with said road, N. 56-15 W. 140.8 feet to the beginning corner.
