All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Anderson, Greenville, lying on the northern side of the Old Easley Bridge Road containing 0.35 of an acre, more or less, and being more particularly shown on a plat made by Robinson Engineering Service dated March 30, 1966, of record in the RMC Office for Greenville County in Plat Book KKK, at page 124.
