NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Mapleton Drive, being shown as Lot 108 of Pine Forest, recorded in Plat Book QQ at Pages 106 and 107 in the R.M.C. Office for Greenville County, and having according to said plat the following metes and bounds, to wit:

"BEGINNING at an iron pin on the northern side of Mapleton Drive, at the joint front corner of Lots 107 and 108, and running thence with the northern side of Mapleton Drive, N. 63-30 E. 100 feet to an iron pin at the corner of Lot 110; thence with line of Lot 109 and Lot 110, N. 26-30 M. 138 feet to an iron pin at corner of Lot 50; thence with line of Lot 50, S. 63-30 M. 100 feet to an iron pin at the corner of Lot 107; thence with line of Lot 107, S. 26-30 E. 138 feet to the point of beginning."

Being the same conveyed to the mortgagors by deed of William C. Owens and Dennis E. Mullikin, Jr., to be recorded herewith.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagors agree to pay to the mortgagee as premium for such insurance one-half of one per cent of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
