"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 16 on a plat of property of Kirkwood Heights recorded in Plat Book EE at pages 110 and 111 in the RMC Office, and having according to said plat the following metes and bounds:
