ALL that lot of land with improvements now or hereafter erected thereon lying on the Northwestern side of Alberta Avenue near the Parker Road in Greenville County, South Carolina, being shown as the Easternmost portion of Lot No. 21 on a Plat of the Property of D. L. Bramlett, recorded in the RMC Office for Greenville County, S.
