"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL THAT CERTAIN PIECE, PARCEL, OR LOT OF LAND, SITUATE, LYING AND BEING IN BUTLER TOWNSHIP, GREENVILLE, COUNTY, SOUTH CAROLINA, WITHIN THE CORPORATE LIMITS OF THE CITY OF GREENVILLE, BEING SHOWN AND DESIGNATED AS LOT NO. 10 OF A SUBDIVISION KNOWN AS HUTTON COURT, A PLAT OF WHICH IS ON RECORD IN THE RMC OFFICE OF GREENVILLE COUNTY, SOUTH CAROLINA, IN PLAT BOOK "NN" AT PAGE 101.

BEGINNING At A Point on the Eastern side of Hutton Court at the joint front corner of Lots No. 10 and No. 11 and running whence N.73-39 E. 173.9 feet so a point at the joint rear corner of Lots No. 10 and No. 11; thence running N. 20-08 W. 65.-5 feet to apoint at the joint rear corner of Lots No. 9 and No. 10; thence running S. 73-39 W. 153.2 feet to a point on the eastern side of Hutton Court at the joint front corner of Lots No. 9 and No. 10; thence fbllowing the curvature of a turnaround at the Northern end of Hutton Court S. 30-37 W. 22.5 feet to a point; thence running with Eastern side of Hutton Court S.16-21 E 49.7 feet to whe point of beginning.

This is a purchase money second mortgage, junior only to that mortgage given on the subject property by Lawrence Eckman, Jr. to Cameron-Brown Company.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
