"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the City of Green, S.C., lying on the South side of Campbell Street and on the West side of an unnamed street, and being further shown as Lot No. 3, on Plat of Property of John Donaldson made by H.S. Brockman, Surveyor, May 23rd, 1958, and having the following courses and distances, to-wit:-
