(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ______ DOLLARS (\$ 19,000.00), with interest thereon at the rate of six & one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate at the

southeastern corner of the intersection of Spring Forest Road and Leacroft Drive, being shown and designated as Lot No. 24 on Plat of Section II of Spring Forest, recorded in Plat Book BBB at Page 34 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Leacroft Drive at the joint front corner of Lots 24 and 25, and running thence with line of Lot 25 S. 36-39 E. 222.8 feet to an iron pin; thence with the rear line of Lot 41 S. 38 W. 126.9 feet to pin on Spring Forest Road; thence with eastern side of said Road N. 36-39 W. 231.3 feet to pin; thence with the curve of the intersection of said Road and Leacroft Drive N. 8-21 E. 38.35 feet to pin on Leacroft Drive; thence with said Drive N. 53-21 E. 98.3 feet to point of beginning.
