"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the village of the Slater Mfg Co., Slater, S. C. as shown on a plat of property of the Slater Mfg co., showing additions to lots along Whitney St. made by Pickell & Pickell, Engineers, March, 1953, recorded in the R. M. C. Office for Greenville County, S. C. , in Plat Book DD at page 121, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at the joint rear corner of Lots 5 and 6 of Block B, and running thence along the rear line of Lot No. 5 N. 13-46 E. 44.1 ft. to the joint rear corner of Lots Nos. 6 and 7 of Block B; thence S. 77-43 E. 102.9 feet to a point; thence S. 13-54 W. 43.1 feet to a point; thence N. 78-17 W. 102.9 feet to the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
