ACCIDENT INSURANCE COMPANY in Chattanooga, Tennessee, or at such other place as the holder hereof may from time to time designate in writing.

"This note and interest are secured by a first mortgage on real estate of even date herewith, on property located in Greenville County, South Carolina.
