All that pieces parcel XxXx for land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Western side of Bahan Road (also known as Bahan Street) in the County of Greenville, State of South Carolina, being known as a portion of Lot No. 9 of a plat entitled "Plat No. 2 - Property of W. S. Bradley by Dalton & Neves dated April, 1945, and recorded in the RMC Office for Greenville County in Plat Book 0 at Page 169 and being further shown as two lots, designated respectively as property of "Hall & Cox" and property of "Taylors Lumber Company" on a plat entitled "Property of Taylors Lumber Co." by T. C. Adams. C. BEGINNING at a point on the Western side of Bahan Road at the joint front corner of other property now or formerly belonging to Taylors Lumber Company as shown on the latter plat above referred to and running thence with the joint line of said property S. 86--30 W. 72.8 feet to a point; thence N. 0--30 E. 100 feet to a point, thence N. 86--30 E 66.6 feet to a point on the Western side of Bahan Road; thence with the Western side of Bahan Road S. 2--30 E. 100 feet to the point of beginning.

The above described premises are shown as Lot Nos. 9 and 9.2, Block 2, Sheet P 15.2 on the Greenville County Tax Maps.

The Southern most of said two lots, being designated on the latter plat above referred to as the property of "Hall & Cox", was acquired by the mortgagor herein by deed from the South Carolina National Bank as trustee under the will of J. B. Hall, and R. E. Cox, by deed dated September 29, 1961 and recorded October 5, 1961 in the RMC Office for Greenville County in Deed Volume 683 at Page 383, and by a subsequent corrective deed to be recorded herewith; the Northern most of the two lots, being designated as property of Taylors Lumber Company on the latter plat above referred to, was acquired by the mortgagor herein by deed of Taylors Lumber Company dated February 12, 1965 and recorded February 19, 1965 in the RMC Office for Greenville County in Deed Volume 768at Page 30.
