MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

therein specified in installments of One Hundred Five and 02/100-----(\$ 105.02) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 25 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 1 of a subdivision known as Addition to Sheffield Forest, as shown on a plat thereof prepared by Piedmont Engineers and Architects, dated May 4, 1965, recorded in the R. M. C. Office for Greenville County in Plat Book III, at Page 122, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Strange Road at the joint corner of Lots 1 and 50 and running thence with the line of Lot 50, N. 9-00 E. 160.0 feet to an iron pin at the joint corner of Lots 1 and 2; running thence with the joint line of said lots, S. 81-00 E. 140.0 feet to an iron pin on the western side of Pinebranch Drive; running thence with the western side of said Pinebranch Drive, S. 23-42 W. 169.7 feet to an iron pin at the intersection of said Pinebranch Drive and Strange Road; running thence with the curvature of said intersection, the chord of which is S. 70-01 W. 34.6 feet to an iron pin on the northern side of Strange Road; thence with the northern side of Strange Road, N. 63-41 W. 70.0 feet to the point of beginning; being the same conveyed to me by Horne Motor Co. by deed dated September 9, 1966 to be recorded herewith."
