NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has greated, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all Improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as a portion of Lots 26 and 27, as shown on a plat of Paris Heights, recorded in Plat Book Y at page 65, and being more particularly described according to a more recent survey prepared by C. C. Jones as follows:

BEGINNING at an iron pin in the Northern side of Arlington Road, in the front line of Lot 26, and running thence with said Road, N. 72-30 E. 35 feet to an iron pin, joint front corner of Lots 26 and 27; thence continuing with said road, N. 72-30 E. 36.1 feet to an ironpin in the front line of Lot 27; thence through Lot 27, N. 17-30 W. 160 feet to an iron pin; thence S. 72-30 W. 71.1 feet to an iron pin in rear line of Lot 26; thence through Lot 26, S. 17-30 E. 160 feet to the point of beginning.
