"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolona being known and designated as Lot No. 23 as shown on a plat prepared by R. K. Campbell, dated May, 1950 and revised July 9, 1959, entitled "Property Plat. P.L. Bruce", recorded in the R. M. C. Office for Greenville County, South Carolina, in plat Book MM at page 123, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Pinedale Drive at the joint front corner of Lots Nos. 22 and 23, and running thence with the line of Lot No. 22 N. 19-27W. 127.% feet to an iron pin; thence N. 70-33 E. 60 feet to an rion pin at the joint rear corner of Lots Nos. 23 and 24; thence with the line of Lot No. 24 S. 19-27 E. 127.5 feet to an iron pin on the Northern side of Pinedale Drive; thence with the Northern side of Pinedale Drive S. 70-33 W. 60 feet to the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
