"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Howell Circle near the City of Greenville, being shown as Lot 53 on plat of Property of Alvin A. McCall, Jr. (being a part of Section 2 of Spring Forest), recorded in Plat Book MMM at page 42, and described as follows:
