"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon. situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on Creighton Street, being known and designated as Lot NU. 18 of a subdivision known as COLONIAL HILLS, SECTION 3, as shown on a plat thereof being recorded in the R.M.O. Office for Greenville County in Plat Book BBB, page 91, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the eastern side of Creighton Street, joint front corner of Lots Mos. 17 and 18, and running thence with the joint line of said lots, S. 80-15 E. 160 feet to an iron pin in the line of Lot No. 142; thence with the side line of Lot No. 142, N. 9-45 E. 125.9 feet to an iron pin on the southern side of Ardmore Drive; thence with Ardmore Drive, N. 83-33 W. 43.9 feet to an iron pin; thence continuing with said Drive, N. 80-47 W. 91.5 feet to an iron pin; thence continuing with Ardmore Drive as it intersects with Creighton Drive, following the curvature thereof, the chord of which is S. 54-29 W. 35.6 feet to an iron pin on the eastern side of Creighton Ptreet; thence with Creighton Street, S. 9-45 W. 95 feet to the beginning corner.
