NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the northwestern side of Wedgewood Drive, in the City of Greenville, being part of Lots Nos. 19 and 20 of Croftstone Acres, as shown on plat thereof recorded in Plat Book E at Pages 35 and 36, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the northwestern side of Wedgewood Drive, in the front line of Lot No. 20, said pin being 821 feet in a northeasterly direction from the point where the northwestern side of Wedgewood Drive intersects with the northeastern side of the National Highway, and running thence on a line through Lot No. 20, N. 33-00 W. 200 feet to an iron pin; thence N. 54-35 E. 70 feet to an iron pin; thence S. 33-00 E.200 feet to an iron pin on the northwestern side of Wedgewood Drive; said pin being 3 feet west from the joint corner of Lots Nos. 19 and 20; thence with the northwestern side of Wedgewood Drive, S. 54-35 W. 70 feet to the beginning corner."
