NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the northwestern corner of the intersection of Sunset Dive and Waccamaw Avenue, being shown as Lot 72 on Plat #2 of Sunset Hills recorded in Plat Book P at page 19 in the RMC Office for Greenville County, and having the following metes and bounds:

Beginning at an iron pin at the northwestern corner of the intersection of Sunset Drive and Waccamaw Avenue, and thence with the northeastern side of Sunset Drive, N. 41-10 W. 75 feet to an iron pin at corner of Lot 71; thence with line of Lot 71, N. 48-50 E. 175 feet to an iron pin on a five-foot strip reserved for utilities; thence with said five-foot strip, S. 41-10 E. 75 feet to an iron pin on Waccamaw Avenue; thence with the northwestern side of said Waccamaw Avenue, S. 48-50 W. 175 feet to the point of beginning.

Being the same property conveyed to the mortgagors by deed recorded in Deed Book ___ at page ___ given by M. L. Lanford, Jr., of even date herewith.
