C. office for Greenville County in Mortgage Book ______ 1051 ____, at page ______ 310 ____ at the rate of \$ ______ 114.79 per month, bearing interest at the rate of 6-1/2 % per annum, payable monthly, and that so long as said payments are made promptly on the first day of each and every calendar month this loan shall not be considered delinquent, but should the mortgagor fail to make said payments as agreed, then, in that event, the holder of this mortgage may institute foreclosure proceedings without further delay according to the terms as set out in said note and mortgage.
