"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, subdivision of property of Carestil McDaniel and Loretta McDaniel, and having according to a plat recorded in Plat Book BB at page 87, being more particularly described as follows:

BEGINNING at an iron pin on the northern side of S. C. Highway 83 corner of property now or formerly owned by Lunsford and running thence with the line of said property N. 19-30 E. 250 feet to an iron pin; thence N. 67-19 W. 100 feet to an iron pin corner of Lot 2; thence S. 19-30 W. 250 feet to an iron pin northern side of Highway 83; thence with the northern side of said highway S. 67-19 E. 100feet to the beginning corner.
