MORTGAGE OF REAL ESTATE

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of Greenvista Lane, and being a portion of Lots Nos. 32 and 33, on plat of Dellvista Heights, recorded in the RMC Office for Greenville County, S. C., in Plat Book "RR", at Page 125, said lots as revised being shown on a revised map of Lots Nos. 32 and 33, of Dellvista Heights, prepared by C. O. Riddle, RLS, September 15, 1966, and having, according to said revised map, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Greenvista Lane, said iron pin being N. 20-58 W. 20 feet from the original front corner of Lots Nos. 32 and 33, and running thence N. 56-23 E., on a new line through Lot No. 32, 142.8 feet to an iron pin in rear line of Lot No. 32; running thence S. 32-47 E. 52.2 feet to an iron pin; running thence S. 42-49 E. 26.8 feet to a new iron pin in rear line of Lot No. 33; thence on a new line through Lot No. 33 S. 31-38 E. 158.4 feet to an iron pin on the northerly side of Greenvista Lane; running thence with the northerly side of Greenvista Lane on a curve, the chord of which is N. 44-40 W., 84.9 feet to an iron pin; thence continuing with the northerly side of Greenvista Lane N. 20-58 W. 43.3 feet to an iron pin, the original joint front corner of Lots Nos. 32 and 33; thence still continuing with the northerly side of Greenvista Lane N. 20-58 W. 20 feet to the point of BEGINNING.
