"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, known and designated as Lot No. 30 of Alta Vista according to a plat of R. E. Dalton, Surveyor, recorded in Plat Book G, in the R. M. C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Crescent Avenue 515 feet east from the southeastern intersection of McDaniel Avenue and Crescent Avenue and running thence with Crescent Avenue S. 82-00 E. 74 feet to an iron pin, joint northern corner of Lots Nos. 30 and 31; thence along the dividing line of Lots S. 8-00 W. 200 feet to a 15-foot alley; thence across said alley 15 feet to an iron pin, joint southwestern intersection of the line of Lot No. 33 and said alley; thence along the dividing line of Lot No. 30 and Lot No. 33 S. 8-00 W. 39.6 feet to an iron pin, joint southern corner of Lots Nos. 30 and 33; thence along the rear line of Lot No. 30 N. 73-09 W. 74.9 feet to an iron pin, joint southern corner of Lots Nos. 29 and 30; thence along the dividing line of said lots N. 8-00 E. 242.9 feet to an iron pin at the beginning corner.
